1) Who is the Data Controller?

2) Which is the legal basis of the data processing?

3) What kind of personal data are processed?

a) Navigation data

The IT systems and software procedures of the Decal Renewables website ("Decal Renewables") to carry out ordinary operations and the use of Internet communication protocols, such as in particular IP addresses, the URI (Uniform Resource Identifier) addresses of the requested resources, the time of the request, the method used in submitting the request to the server, the size of the file obtained in response, the numeric code indicating the status of the response given by the server (success, error, etc.).

These data are used only to obtain statistical information on the use of the site and to check its correct functioning. The aforementioned data could be used to ascertain responsibility in the case of computer crimes against the website of http://venicelng.it/ to other sites connected or connected to users of the site http://venicelng.it/ and, in these cases, kept for the time necessary for ascertaining the responsibilities in court.

b) Data provided spontaneously by the user

The optional, explicit and voluntary sending of electronic mail to the addresses indicated on this site entails the subsequent acquisition of the sender's address, necessary to respond to requests and any other personal data included in the message. Specific summary information could be progressively reported or displayed on the site pages set up for particular services on request.

c) Cookie

We do not use cookies for user profiling, neither other tracking methods.

Instead, only session cookies are used (not persistent) in a manner strictly limited to what is necessary for efficient site navigation (technical cookie).

Cookies are small text files sent by the browser that improve the functioning of the website.



You can disable or accept cookies by properly configuring your browser. Depending on this, browsing may not be easy and some sections or features of the site may be unavailable.

4) What are the processing methods?

5) Who are the data recipients?

6) What are the rights of data subjects?

7) The right to lodge a complaint

Data subjects who believe that the processing of personal data referring to them carried out through this site is in violation of the provisions of the Regulation have the right to lodge a complaint with the Guarantor, as provided for by art. 77 of the same Regulation, or to take the appropriate judicial actions (art. 79 of the Regulation).
